Subject: Carving Enterprise Seals and Enterprise Signage

Pursuant to the Law on Enterprises (Revised) 2013;

- Pursuant to the Law on Signs 2018;
- Pursuant to the Decree on Seals No.322/GOV, dated 1 October 2018;
- Pursuant to Sub-paragraphs 7.1.2.1 and 1.2.1 of the Order No.02/PM, dated 1
 February 2018 on the Improvements of Regulations and Coordination Mechanism in
 Business Operations in Lao PDR.

To ensure effective implementation of enterprise carving enterprise seals and enterprise signage as defined in the laws and regulations, aiming at enabling "Start-up business" to be smooth [and] fast, the Permanent Secretary Office of the Ministry of Industry and Commerce would like to notify relevant stakeholders for implement as follows:

A. Carving seal

After enterprise registration, the respective enterprise may its enterprise registration license to present to the Public Security Sector for carving an enterprise seal as defined in Article 21 (new) of the Law on Enterprises (Revised) 2013 and Article 22 of the Decree No.322/GOV, dated 1 October 2018 on [Enterprise] Seals. It is prohibited to issue a carving seal permission;

B. Enterprise Signage

- 1. After an investor is granted an enterprise registration license (individual or legal entity), it shall present its enterprise registration license to the [sign company] to produce an enterprise signage without applying for a permission as used to practice in the past.
- 2. Contents of enterprise signage shall include:
 - Enterprise name as specified on the enterprise registration license;
 - Enterprise identification number;
 - Tax identification number (if any);
 - Telephone number (that could be contacted).

In addition to contents as mentioned above, the enterprise may add its logo or QR Code on the top right of the enterprise signage.

Every time, when contents of enterprise registration license are changed that caused changes in the contents of enterprise signage, such enterprise shall produce a new enterprise sign name accordingly.

- 3. Foreign language used in the enterprise signage shall be only in English as specified on the enterprise registration license. Lao and English languages on such enterprise signage, Lao language shall be above English language and the size of English letters shall not be larger than two thirds (2/3) of the size of Lao language;
- 4. The size of enterprise signage shall be fit to the location or space where the sign would be installed without causing [negative] impacts on the natural scenery, surrounding environment, safety, causing problems to the traffic, however, the minimum size of the sign shall not be less than 30x60 centimeters and maximum shall not be more than 1.5 meters x 3 meters;
- 5. The background color and letters of the enterprise signage shall be white background with red letters and the private individual enterprise and collective enterprise shall be in yellow background with red letters;
- 6. The enterprise signage is a symbol indicating basic identification of the enterprise to the public. The installation an enterprise signage shall be at the front of the [enterprise] office or where the enterprise is located (in case of small enterprise that has an office located at the same place of business operations such as retailer or grocery shop);
- 7. The enterprise shall select contents of its enterprise signage as deemed appropriate either as specified under Appendix I nor II of this Notice;
- 8. The relevant enterprise registrar shall post or display Appendix I and II as specified in paragraph 7 of this Notice at any spot that is deemed convenient for investors to take photos or make photocopy. In addition, investors or interested party may access or download from the website of Department of Enterprise Registration and Management (www.erm.gov.la);
- 9. This Notice enters into force from the 5th of December 2018 and replaces Notice No.1542/PSO.DERM, dated 21 June 2018 on Carving Enterprise Seals and Signage.
